PRESIDENT REPORT

As I pause and consider the past year in rowing across Canada, I am reminded about the innovative pathways that clubs in Canada take to be successful. Such a range of opportunities engages people from many walks of life to participate in our sport. Our organization was awarded substantial Federal Government funding from the "Canadian Sport for All" Initiative to be used to support inspired thinking to engage activity at clubs across Canada. Working closely with our Provincial Rowing Associations and our clubs, many new and distinctive ideas were submitted to grow rowing with a more diversified approach. Having funds to try new ideas and new forms of outreach into the community will lay the ground work for future endeavours and we all will learn from each other.

Canadian rowers continue to broaden their approach to our sport and are enjoying new opportunities. Our Indoor rowing initiatives have taken root during the winter season that was still in a virtual stage last winter. As we moved into spring, we were able to return to the water and enjoy recreational leagues, Learn to Row programs as well as competitive programs and regattas. The return of the Canadian Secondary Schools Rowing Association Championships was exciting as well as the Royal Canadian Henley Regatta after a two year absence. The postponed Canada Summer Games took place in Niagara and young rowers from across the country competed for their province. The Canadian Masters Regatta was enjoyed by many and the National Rowing Championships were held on Lake Quamichan, home of the National Training Centre, for the first time. Canadian rowers are also enjoying Coastal Rowing and Beach Sprint opportunities in greater numbers. A diverse approach for our diverse waterways!

Earlier this year, concerns were raised regarding governance, management and high performance aspects of this organization.

The RCA Board struck a Task Force to review the concerns and to manage the selection process to select an independent third party to complete a cultural review of the National Training Centre. The Board received the report, accepted all of the recommendations issued by Rubin-Thomlinson LLP and have set to work to strengthen the steps that RCA has already taken and implement improved practices to better the organization.

In closing, I must thank the staff at RCA for their tenacity as we have moved through some difficult times in the last few years. Our CEO, Terry Dillon, has led the organization through unprecedented times, times with no playbook, and kept us moving forward. The small but mighty team continues to dedicate time and energy to streamline services and products and to help Canadian rowers across the country. Also, thank you to the RCA Board, for your commitment of time and expertise as we address the needed changes in this organization to move from good to great.

CEO REPORT

This has been quite the year. A year of achievement and a year of challenge, as we continue to emerge from the shadow of the Pandemic.

Covid-19 forced us to be creative and taught us how to innovate. We saw the growth of virtual rowing, and last year we piloted The Great Indoors, this is a new annual event that engages our entire community. The innovation and future proofing continued thanks to our Safety and Events Committee and many others that contributed to the development of our online interactive Water Safety Modules. We should expect to see more of our educational content delivered in this more engaging and accessible format in the future.

Safe Sport and the safeguarding of athletes continues to be an important aspect of the administration of sport in Canada. I want to acknowledge the work that has been done by Jen Fitzpatrick and her team, in partnership with Provincial Associations and broader Membership to ensure we have a robust Safe Sport framework for dealing with maltreatment and misconduct in our sport. This policy framework has allowed our joining of the new federal Office of the Sport Integrity Commissioner (OSIC) to be seamless.

A key focus, post Tokyo, was to make our high performance programs more people-centred. The Rubin-Thomlinson independent review of the culture in our programs has informed ongoing improvements to athlete support, communication and representation in decision making. We have introduced independent oversight of selection. We have enhanced onboarding, hiring practises and performance management. We have more to do but we feel good about the one team ethos that now exists in our programs.

We continue to enjoy podium success on the international stage. Congratulations to all our athletes and to those that achieved medal success at U23 and Senior World Championships. We know there are more good things to come as we head into qualification for Paris. We are especially proud that these results were achieved with the support of an entirely Canadian coaching team.

One of our Strategic Goals is to introduce 5K new participants to our sport by 2025 Firstly, we are seeing people return to rowing, based on current

trends we expect to exceed pre-pandemic registration for 2022/23. We can celebrate the success of a coordinated National Come and Try Day where we saw 30% of Come Try participants join a club and staying in our sport. We have yet to see the full impact of \$1m investment in our grass roots programs made possible by the Canadian Sport for All initiative. We are proud to see unprecedented numbers of Canadians are enjoying our sport as a way of connecting with their communities.

Coastal Rowing and Beach Sprints are growing with existing events taking on a new significance and the emergence of new events like the Beach Sprint Series. We are learning, developing capability, growing participation, and having success on the World stage. We sent teams to World Rowing Beach Sprint Finals in Wales and to the Commonwealth Rowing Association Beach Sprints Championships in Namibia. We have qualified a full team for the World Beach Games that will take place in Bali next year. These are exciting times for the growth of our sport.

We expect to be sharing more in the coming weeks about other work being done including plans for a revised Canada Cup, the development of an Indoor Instructor qualification, and the launch of a Made in Canada coaching initiative.

None of this would be possible without our Provincial partnerships and the hard work of the staff at Rowing Canada. I want to acknowledge and thank Jen Fitzpatrick, Adam Parfitt, Colleen Coderre, and Kim Bell for their unwavering support.

Finally, I want to recognize that rowing in Canada operates because of the countless hours given freely by volunteers. It is the coaches, the officers, the officials, the umpires, that make the running of our clubs and events possible. Sport has a unique ability to promote physical and mental wellbeing, to create community, and to elevate the human spirit. It is your work and commitment that creates the opportunity for our members to enjoy the benefits of our sport.

TREASURER'S REPORT

The audited financial statements for the Canadian Amateur Rowing Association for the year ended March 31, 2022, are provided for your review.

- The excess of revenue over expenditures is \$858,487. This is made up of 3 components, first the operational excess of \$452,586, second the NTC Net Contributions of \$374,876 and a gain on sale of capital assets of \$31,025. This is more than our initial budget which forecast an operational excess of \$1,276.
- The reason for the excess operationally is due to the difference in Sport Canada approach to operational capital and the cash versus accrual accounting practices used in the Audited Financial statements. When this is considered then we spent \$392,999 and removing this from operational excess the final cash result was a surplus of \$59,587.
- The Covid support in fiscal 2022 was \$444,482 compared to \$1,234,500 in fiscal 2021. The funds received were used as indicated in note 12 to the financial statements.
- 4 We were pleased to see the increase 58% in membership fees as the sport returned to normal.
- The Sport Canada funding increase is due to the deferral of \$1,020,501 of fiscal 2021 funds that were required to be used by September 2021.
- The balance of the revenue increases relates to the return to normal of camps, events, and fundraising (Crowd Funding) for Junior, NexGen programs as example in later part of fiscal 2022. Note that for second year no funds were received from the Henley Regatta nor was there an inperson conference.
- 7 In Communications, marketing, and initiatives the increase is primarily due to the Row to Tokyo program (\$23,020).
- The reduction in Membership Services is due to the Membership Emergency Relief and Support and Grants for Phase 1,2 and 3 that were in place fiscal 2021 to provide financial and other forms of support to the clubs for Covid complications, financial hardship, and sport development. In fiscal 2022 we received Covid recovery Fund and note 12 details how this was spent.
- Governance and National Operations Schedule 1 is down due to the legal expenses reduction as 2021 had substantial Safe Sport related legal costs in National Office Operations.
- The High-Performance expenses for fiscal 2022 was higher by 34% due to the Olympics, pre-Olympic camps, world Cups, Junior Worlds, U23's. Support for this was through the deferred Sport Canada funds noted earlier. We also had new hires on the sport medicine side and all related cost for medical for the Olympics. Staff was reduced which occurs in the post-Olympic period from September to March. We have a higher level of amortization resulting from the operational capital we invested in, some required for Covid bubbles and supported by Sport Canada and Heritage Canada. This will continue in future as for 2021 and 2022 the total invested was \$894,948. Lastly the NTC in Quamichan is operational with temporary structures and the use for the Duncan Community Lodge facility.



- On the Domestic Side schedule 3 the increases are mainly in the RCA Regatta's and Events as funds were spent on National Events, Indoor Rowing Regatta's and Event Participation (funded by the COVID-19 Recovery Funds for \$57,500). We also have increased cost in the Safe Sport, Diversity, Inclusion and Gender Equity space due to safety in sport programs for an additional \$48,000.
- 12 Our cash resources are down as we expended the Sport Canada deferral funds.
- Our accounts receivable Increases from \$64,643 to \$254,076 which reflects activity Increases and grants of \$140,000 receivable at year end. In addition, our prepaids Increased from \$327,215 In 2021 to \$479,722 this fiscal and has \$251,725 of expenses prepaid for this fiscal for National Team world cup and championships permitted to be paid from Sport Canada funds in current year.
- Our accounts payable are up as result of the \$375,000 of Grants allocated on March 31 but paid in April and the new NTC dock of \$137,000.
- As indicated the deferred revenue was reduced as the Sport Canada support deferral was spent by September 2021.
- We finish the year with an increase in our Unrestricted Fund balance by \$189,429 bringing our level to \$916,510. Our efforts have been too slowly to strengthen our equity position to ensure in future we are financially sound. The Internally restricted has increased by \$372,566 and this relates to the net contributions received as of March 31 on the National Training Center project.

As noted in past we have a talented team of people at Rowing Canada Aviron and again they have produced a financially successful year. Pressures are mounting from inflation, rising cost, and access to funding. It will be difficult in future to repeat this, but our goals are to continue to make Rowing Canada Aviron stronger financially.

I would like to thank RCA Staff, Supporters and Volunteers for their contributions in successfully navigating these difficult times.



 Number of rowers registered for programs from April 1, 2020 -March 31 2021










RCA MEMBER ORGANIZATIONS WITH O PARTICIPANTS

INDEPENDENT AUDITOR'S REPORT

To the members of Canadian Amateur Rowing Association

OPINION

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

RESPONSIBILITIES OF MANAGEMENT AND THOSE CHARGED WITH GOVERNANCE FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Association or to cease operations, or has no realistic alternative but to do so.


Those charged with governance are responsible for overseeing the Association's financial reporting process.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Association to cease to continue as a going concern.

NOTES TO FINANCIAL STATEMENTS - YEAR ENDED MARCH 31, 2022

1. PURPOSE OF THE ASSOCIATION

Rowing Canada Aviron is the operating name of the Canadian Amateur Rowing Association - Association Canadienne d'Aviron Amateur (the "Association") which is a not-for-profit organization incorporated under the Canada Not-for-profit Corporations Act. As a not-for-profit organization, the Association is exempt from the payment of income tax.

As a Registered Amateur Athletic Association it is authorized to issue receipts for tax purposes for the donations it receives.

The Association's principal activity is the development of the sport of rowing in Canada and it is recognized by the Government of Canada and the Canadian Olympic Committee as the national governing body for the sport of rowing.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF PRESENTATION:

The financial statements were prepared in accordance with Canadian accounting standards for not- for-profit organizations ("ASNPO"). As a result these financial statements are in accordance with Canadian generally accepted accounting principles ("Canadian GAAP").

REVENUE RECOGNITION:

The Association follows the deferral method of accounting for contributions.

Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Donation revenue is accounted for when received. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Pledges from donors are recorded when payment is received by the Association or the transfer of property is completed. Donations received for the acquisition of property or to support future operations are recorded as deferred amounts.

Membership fees are recognized as revenue in the period of membership eligibility.

INTERNALLY RESTRICTED NET ASSETS:

Net assets that are internally restricted have been designated by the Association for specific uses. Internally restricted resources can be made available for other purposes.

CASH AND CASH EQUIVALENTS:

Cash and cash equivalents consist of cash on hand and balances with banks.

TANGIBLE CAPITAL ASSETS:

Purchased assets are stated at cost less accumulated amortization. Contributed assets are recorded at fair value at the date of contribution. Tangible capital assets are amortized over their estimated useful lives on a straight-line basis at the following rates:

FINANCIAL INSTRUMENTS:

The Association's financial instruments consist of cash and cash equivalents, accounts receivable and accounts payable and accrued charges. Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expressed when incurred.

MEASUREMENT UNCERTAINTY:

The preparation of financial statements in conformity with Canadian accounting standards for not-forprofit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosures of contingent assets and liabilities as at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates. The Association's material estimates include the collectability of accounts receivable, deferral of revenue, accrual of accounts payable, and the useful life of tangible capital assets.

CONTRIBUTED MATERIALS AND SERVICES:

Donated tangible capital assets and rent is recorded at fair value when received if fair value can be reasonably determined.

The Association is dependent on the voluntary service of many members and other. Since these services are not normally purchased by the Association, and because of the difficulty of determining their fair value, donated services are not recognized in these financial statements.

- The Umpire's Reserve Fund relates to amounts raised by the 2001 World Masters Rowing Regatta Organizing Committee to be used for the education and development of umpires within Canada.
- The Sustainable Organization Reserve Fund provides a source of funds for future financial needs.
- In 2021, an internally restricted fund was established to accept donations and contributions for the National Training Centre at Quamichan Lake. These donations are used for expenditures of the Centre. In 2022, \$529,667 was received and \$2,950 was expended for dock permits. In addition, \$151,541 was spent on consultants for fund raising.

9. FINANCIAL INSTRUMENTS

The Association is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Association's risk exposure and concentration as of March 31, 2022.

(A) CREDIT RISK

Credit risk arises from the potential that a counter party will fail to perform its obligations. The Association is exposed to credit risk from members. An allowance for doubtful accounts is established based upon factors surrounding the credit risk of specific accounts, historical trends and other information. The Association has a significant number of members which minimizes concentration of credit risk. The credit risk regarding cash and term deposits is considered to be negligible because they are held by a reputable financial institution with an investment grade external credit rating.

(B) LIQUIDITY RISK

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Association is exposed to this risk mainly in respect of its receipt of funds from its funders, members and other related sources, and accounts payable and accrued charges.

(C) MARKET RISK

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency risk, interest rate risk and other price risk. The Association is mainly exposed to currency risk.

Unless otherwise noted, it is management's opinion that the Association is not exposed to significant interest rate risk or other price risks arising from these financial instruments.

(I) CURRENCY RISK

Currency risk is the risk to the Association's excess of revenue over expenses that arise from fluctuations of foreign exchange rates and the degree of volatility of these rates. The Association is exposed to foreign currency exchange risk on accounts payable held in foreign denominations. The Association does not use derivative instruments to reduce its exposure to foreign currency risk.

10. LEASE COMMITMENT

The Association entered into a lease agreement in the year for training and fitness facilities.

11. COMPARATIVE FIGURES

The financial statements have been reclassified, where applicable, to conform to the presentation used in the current year. The changes do not affect prior year earnings.

12. IMPACTS OF COVID-19

During the year ended March 31, 2022 the Association received \$444,482 from COVID-19 Recovery Funds for Cultural, Heritage and Sport Organizations administered through Heritage Canada. For the year ended March 31, 2021 the Association received \$1,234,500 from the COVID-19 Emergency Relief Fund. The goal of these Funds was to ensure business continuance for organizations whose viability has been negatively affected by COVID-19.

13. IMPACTS OF COVID-19

TOTAL EXPENDED

The outbreak of a novel strain of coronavirus ("COVID-19") was declared a global pandemic by the World Health Organization in March 2020. COVID-19 has severely impacted many economies around the globe. In many countries, including Canada, businesses were forced to cease or limit operations for long periods of time. Measures taken to contain the spread of the virus, including travel bans, quarantines, social distancing, and closures of non-essential services have triggered significant, disruptions to businesses worldwide, resulting in an economic slowdown. Global stock markets have also experienced great volatility and a significant weakening. Governments and central banks have responded with monetary and fiscal interventions to stabilize economic conditions.


