Coxswain, Kristen Kit steered the crew of Abby Dent, Kristina Walker, Sydney Payne, Avalon Wasteneys, Kasia Gruchalla-Wesierski, Maya Meschkuleit, Caileigh Filmer, and Jessica Sevick down the course for an exciting finish in a very competitive field. Congratulations to these women for their grit and determination for this podium spot!

We also cheered on Jacob Wassermann, in his Paralympics debut, as he came 10th overall in the PR1 Men's Single event. He is looking forward to continuing to learn and prepare for LA in 2028!

Also on the world stage, 83 Canadian athletes rowed in the World Senior, Under 23 and Under 19 Championships held in St. Catharines! It was exciting to watch our developing Canadian athletes have the experience of international competition so close to home where families and friends could travel to cheer them on. Congratulations to Organizing Committee Chair, Bill Schenck for his leadership in presenting the 2024 Mega Worlds in a world class standard. Over 700 volunteers came forward to ensure the event's success!

Thank you to the RCA Board of Directors, for their continued diligence in carrying on the decisions of Boards before them and, in particular, for furthering the development of the National Training Center and securing a home for our National Team Athletes and staff. These decisions are about the future. Consistency in this regard, allows security for those aspiring to reach their dreams. It also allows for the development of infrastructure to support our National Team as they train for their goals in our sport. Let's work together to enhance the project that has been in the works for many years to create conditions for team success.

The Strategic Plan will be launched in early 2025. Work began with RCA and Provincial Rowing Association leaders meeting last January to discuss the future of rowing in Canada and the priorities that would guide us to create a Strategic Plan for 2025 – 2028. Thank you to the members who participated in the Strategic Plan survey. Your input was very helpful to inform the next steps.

In May of this year our CEO, Terry Dillon, announced his resignation from RCA. After 7 years, he had navigated this organization through some very difficult times with a mindset that we can always do better, resulting in some progressive changes, making RCA one of Canada's leading National Sport Organizations. We thank him for that. The RCA Board launched into a CEO search while Jennifer Fitzpatrick stepped into the role of Interim CEO. Thank you, Jen, for your deep commitment to continuing the work of the organization through this time of change. RCA is pleased to now welcome Jeff Powell as Chief Executive Officer. Powell will be working closely with the RCA Board of Directors, Senior Leadership and community partners to deliver on the organization's long-term vision.

CEO REPORT

It has been such a pleasure to bring a spotlight to some of the great achievements of RCA and our entire rowing community from over the past year. As I reflect on 2024, I am grateful to have been so close to the many wins and ways we have moved our sport forward. We've also faced several challengesmany of which have provided us the clarity needed to make improvements moving forward.

An Olympic/Paralympic year always comes with so much excitement and extraordinary attention on our sport. We are extremely proud of the Women's Coxed Eight for their silver medal in Paris as well as the other athletes and support staff who contributed to the success in Paris. Another highlight for us was the late qualification in the PR1 Men's Single Sculls, by Jacob Wassermann and the positive attention that it garnered for Para rowing in Canada.

By far the most profound game-changer for participation in rowing was the 'Community Sport For All' Initiative. We received over \$1.3M from Sport Canada for programming and resource development and over 40 clubs across the country delivered programs for more than 4000 individuals from equity deserving populations. At the core of the success of this program is the concept of "nothing for us without us" and a requirement of this program was the creation of partnerships between clubs and local community groups. Many of these relationships that exist now are here to stay and will be the foundation for a successful legacy of this wonderful program.

We continue to hear from our community and other nations about the successful delivery of the 2024 World Rowing Championships, held in St. Catharines, ON this past August. It really was a testament to the experience and wisdom that exists in event delivery in St. Catharines and we are very grateful to Bill Schenck and the team for delivering such an extraordinary event in Canada. During the event, some of our Canadian Umpires were completing their World Rowing Umpire Licensing Exam – congratulations to Kris Davis (BC), Audra Vair (AB), Richard Koo (ON), Marie-Sophie Desaulniers (ON) and Julie-Ann Vincent (NS) all of whom are now World Rowing Umpires.

During the 2024 World Rowing Championships, Team Canada had some successes mixed in with some disappointing results. Many athletes and coaches were exposed to international standards that they otherwise would not have, and our collective challenge is to now turn those experiences into elevated programming along the pathway. We are already making changes to our approach to ensure improved results in the season ahead.

In closing, I want to express how appreciative I am of all the support I have received while in the Interim CEO role since July 1. Even though it was for a short period, I can share that it is a very rewarding role to hold. A very special thanks to Adam Parfitt, our High Performance Director, who went above and beyond with support, and Provincial leadership and Alumni who were there to help me navigate the last 6 months of 2024.



Thank you to the RCA Board of Directors, particularly Carol Purcer, for providing me with this extraordinary opportunity.

There is so much to look forward to in 2025, including a new RCA Strategic Plan, and I'm so pleased to be part of that journey with all of you.

The Audited Financial Statements for the fiscal year ended March 31, 2024, were presented to the membership in September 2024.

The following is a summary of the results outlined in the statements.



Rowing Canada Aviron (RCA) received a "clean" audit. The auditors confirmed that the statements fairly represented the financial position of RCA.



The Statement of Operations shows that a surplus of \$247,328 was generated in the 23/24 fiscal year. (compared to a deficit of \$100,665 the previous year). Of Important note, RCA was successful for the second year in a row to be granted CSAI funding from the federal government. Most of this funding was a flowthrough to the club level having a very positive impact on club operations in several areas of the country.



The Statement of Financial Position confirms that the overall financial position has improved slightly over the previous year, largely due to the increase of the internally restricted net assets as compared to a year ago. (\$530,111 (23/24) vs \$82,552 (22/23)).



The March 31, 2024, balances in both accounts receivable and accounts payable are abnormally high simply as a result of timing of the actual release of committed funds from Sport Canada. The largest component of this is related to funds committed, but not yet released as of March 31, 2024, directly related to the 2024 World Rowing Championships that were held in St. Catharines, Ontario in August.



The Internally Restricted Net Assets are detailed In Note 9 of the statements. The total balance on March 31 of \$530,111.00 is comprised of two funds:

a. Sustainable Organization Reserve \$113,070

b. National Training Centre (Development Project)\$417,041

As noted in the fall presentation of the statements, the balance of the Sustainable Organization Reserve is far too low for an organization such as RCA. In the months ahead, RCA will be working to develop a longterm strategy to work to build up this fund.

Greater detail on the National Training Centre fund can be found in Note 9 to the statements.

The National Training Centre Development Project was the subject of much discussion through the audit presentation process including items addressed in Notes 5, 9 and 11 of the statements.

RCA has committed to completing two things through fiscal 24/25 with respect to this project:

i. A much more robust communication process with regard to the project, starting with a complete status report later in the fiscal year.

ii. Reviewing and updating the accounting and reporting structures of the project for greater transparency for RCA's stakeholders.



Schedules 1, 2 and 3 can be found on the last page of the audited statements. These schedules provide further breakdowns of the annual expenditures into the 3 operational "buckets" of RCA.

SCHEDULE 1 -GOVERNANCE AND NATIONAL OPERATIONS

RCA cut expenses by approximately \$200,000 from this area compared to the previous year. Some of the reduced expenditure was directly related to governance related grant cuts, however the majority of these savings were achieved by an aggressive "no frills" approach to expense management.

SCHEDULE 2 -HIGH PERFORMANCE (OPERATIONS)

23/24 was the final year of preparation leading into the critical last year of the quad, which not only included preparation for the 2024 Olympic Games, but also the 2024 "Mega Worlds" being hosted here in Canada. Minor expense increases leading into the summer of 2024 were expected, planned, and very well-managed throughout this period.

SCHEDULE 3 -DOMESTIC DEVELOPMENT

As shown by the results, we have continued to work hard to manage expenses in this area with significant reductions in most areas compared to the previous year. The two-line items in this area that show significant increases are both a result of the net impact of two federally funded initiatives, specifically the CSAI funding which is reported within the Sport Development line, and the flow through hosting funds for the 2024 World Rowing Championships.

We continue to work very hard to optimize our resources to deliver everything we can, with what resources we have available. Costs will continue to rise, and government funding will continue to fall short of our needs.

As we look ahead to LA' 28 and continually expand expectations of all stakeholders, we must continue the work to find innovative ways to work better, work smarter and work together to maximize the resources we have in our sport.

2024 RCA NATIONAL ROWING CHAMPIONSHIPS - WELLAND, ONTARIO



We would also like to extend our congratulations to all athletes who raced with the maple leaf on their blades in 2024.







NOTES TO FINANCIAL STATEMENTS - YEAR ENDED MARCH 31, 2024

1. PURPOSE OF THE ASSOCIATION

Rowing Canada Aviron is the operating name of the Canadian Amateur Rowing Association -Association Canadienne d'Aviron Amateur (the "Association") which is a not-for-profit organization incorporated under the Canada Not-for-profit Corporations Act. As a not-for-profit organization, the Association is exempt from the payment of income tax.

As a Registered Amateur Athletic Association it is authorized to issue receipts for tax purposes for the donations it receives.

The Association's principal activity is the development of the sport of rowing in Canada and it is recognized by the Government of Canada and the Canadian Olympic Committee as the national governing body for the sport of rowing.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF PRESENTATION:

The financial statements were prepared in accordance with Canadian accounting standards for not- for-profit organizations ("ASNPO"). As a result these financial statements are in accordance with Canadian generally accepted accounting principles ("Canadian GAAP").

REVENUE RECOGNITION:

The Association follows the deferral method of accounting for contributions.

Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Donation revenue is accounted for when received. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Pledges from donors are recorded when payment is received by the Association or the transfer of property is completed. Donations received for the acquisition of property or to support future operations are recorded as deferred amounts.

Membership fees are recognized as revenue in the period of membership eligibility.

INTERNALLY RESTRICTED NET ASSETS:

Net assets that are internally restricted have been designated by the Association for specific uses. Internally restricted resources can be made available for other purposes.

CASH AND CASH EQUIVALENTS:

Cash and cash equivalents consist of cash on hand and balances with banks.

TANGIBLE CAPITAL ASSETS:

Purchased assets are stated at cost less accumulated amortization. Contributed assets are recorded at fair value at the date of contribution. Tangible capital assets are amortized over their estimated useful lives on a straight-line basis at the following rates:

FINANCIAL INSTRUMENTS

The Association's financial instruments consist of cash and cash equivalents, accounts receivable and accounts payable and accrued charges. Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expressed when incurred.

MEASUREMENT UNCERTAINTY

The preparation of financial statements in conformity with Canadian accounting standards for not- forprofit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities. disclosures of contingent assets and liabilities as at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any

adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates. The Association's material estimates include the collectability of accounts receivable, deferral of revenue, accrual of accounts payable, and the useful life of tangible capital assets.

CONTRIBUTED MATERIALS AND SERVICES

Donated tangible capital assets and rent is recorded at fair value when received if fair value can be reasonably determined.

The Association is dependent on the voluntary service of many members and other. Since these services are not normally purchased by the Association, and because of the difficulty of determining their fair value, donated services are not recognized in these financial statements.

INVESTMENTS

The Association accounts for its joint arrangements using the cost method.

10. FINANCIAL INSTRUMENTS

The Association is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Association's risk exposure and concentration as of March 31, 2023.

(A) CREDIT RISK

Credit risk arises from the potential that a counter party will fail to perform its obligations. The Association is exposed to credit risk from members. An allowance for doubtful accounts is established based upon factors surrounding the credit risk of specific accounts, historical trends and other information. The Association has a significant number of members which minimizes concentration of credit risk. The credit risk regarding cash and term deposits is considered to be negligible because they are held by a reputable financial institution with an investment grade external credit rating.

(B) LIQUIDITY RISK

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Association is exposed to this risk mainly in respect of its receipt of funds from its funders, members and other related sources, and accounts payable and accrued charges.

(C) MARKET RISK

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency risk, interest rate risk and other price risk. The Association is mainly exposed to currency risk.

Unless otherwise noted, it is management's opinion that the Association is not exposed to significant interest rate risk or other price risks arising from these financial instruments.

(I) CURRENCY RISK

Currency risk is the risk to the Association's excess of revenue over expenses that arise from fluctuations of foreign exchange rates and the degree of volatility of these rates. The Association is exposed to foreign currency exchange risk on accounts payable held in foreign denominations. The Association does not use derivative instruments to reduce its exposure to foreign currency risk.

11. LEASE COMMITMENTS

The Association holds leases with the Quamichan Rowing Foundation for land (10 years), the Duncan Community Lodge Society for the Training Facility (2 years), and Sprott Road Business Park for the Fitness Centre (3 years).
